**New Business:**

Mayor advised that sludge hauling will take place next week, utilizing a new company. He also reported that a DPW worker is leaving this month and we have begun advertising for the position, taking application until October 15.

**Old Business:**

Mayor Holeman met with Steven's Disposal representative regarding pricing. He will ask him to attend a Council meeting to explain pricing. Mayor also reported a meeting took place last week with the contractor, engineer and the City in regards to water project.

**Council Reports:**

Bauer asked if the Library roof drainage issue can be addressed before winter. Mayor Holeman hopes to accomplish that when they tie in the new water main and the sidewalk is torn up.

Cilley reported state grants for streets may be available early next year.

Tollison suggested decorating with cornstalks on light poles downtown next fall and possibly planting rose bushes near welcome signs. Kristy Alessi stated she would take on the cornstalks.

**Employee Reports:**

Treasurer Goodin reported citizens have concerns about visibility on Railroad Street coming into the City at the new asphalt path and asked if foliage could be trimmed by the school or road commission. Goodin also reported that we have received half, \$59,033, of the ARPA monies.
