The Meeting was called to order at 7:00 p.m. by Mayor Holeman.

Health care rates to increase. The Mayor has been contacted by Bryan Hughes and given an allowance for an early renewal. The health care insurance was discussed and a meeting will be scheduled with the employees.

Moved by Tollison that Advanta be allowed a water tap for sanitary use only. Supported by Schadewald.

The school has requested a "no burning of leaves during school hours" (11:30 a.m. to 3:00 p.m.)  
The water tower was discussed and the Mayor informed Council about the issues with the mixer and requiring a diver in the spring. Payment options were also discussed.  
Moved by Bruckner that we not pay Utilities Services until the mixer is working properly. Supported by Haller. Aye (7) Nay (0) Motion carried.  
The Library will be hosting a Tea on Dec. 7<sup>th</sup>  
Haller reported that the Pre-school program and the outstanding job being done.

Moved by Bruckner that Council approve the annual donation to the PVFD in the amount of \$275.00
