A Regular Meeting of the Council for the City of Petersburg was held on the above date.
The Meeting was called to order at 7:00 p.m. by Mayor, James W. Holeman
Councilpersons present were Charles Bruckner, Dawn Cilley, and Joanne Tollison.
Absent: Terri Bauer, Kevin Richards, Lawrence Schadewald

Moved by Tollison to approve the agenda as printed. Supported by Bruckner. Aye (4) Nay (0) Absent (3) Motion carried.

Minutes of the last meeting were presented to Council in printed form as recorded.
Moved by Bruckner that the minutes of the previous meeting, 2/4/19, be approved.
Supported by Cilley. Aye (4) Nay (0) Absent (3) Motion carried.

Invoices were presented to council in printed form by accounts: General fund- \$22,773.98; Police fund- \$24,234.86; Major St.-\$2,478.82; Local St.- \$844.13; Sewer fund- \$7,458.67; Water fund- \$32,949.87 for a total of \$90,740.33. Moved by Tollison that the invoices as presented be approved and checks drawn for the same.

Public Comment:

A resident voiced concern about several blight issues on E. Center Street and asked if any streets will be worked on this year. Mayor Holeman assured him that the blight will be taken care of and there are no plans to improve streets until after the sidewalk project is complete.

New Business:

Moved by Tollison to accept the bid from Monroe County Road Commission of \$8,255.52 to chip seal Railroad Street from Elizabeth to Division when the township portion is done. Supported by Bruckner. Roll Call Vote: Aye (4) Nay (0) Absent (3) Motion carried.

Old Business:

Tabled lawn mower purchase until next month.

Still waiting on additional bids for master plan updating. Planning Commission will make a decision at their March meeting.

Mayor is waiting for return call from Dundee Township supervisor regarding zoning variance on proposed land purchase on Ida West Road for pump station.

D & P Communications submitted blueprints for upcoming construction project. They have supplied \$20,000 surety bond and the contractor has \$2million insurance policy. Work due to begin in May, all cable will run in front of homes, eliminating any in alleys.

Mayor reported the dump truck recently had clutch adjusted and then 2 rear springs broke and were replaced.
