A Regular Meeting of the Council for the City of Petersburg was held on the above date.  
The Meeting was called to order at 7:00 p.m. by Mayor, James W. Holeman  
Councilpersons present were Terri Bauer, Charles Bruckner, Rich Haller, Kevin Richards, and Joanne Tollison.  
Absent: Lawrence Schadewald

Minutes of the last meeting were presented to Council in printed form as recorded.  
Moved by Richards that the minutes of the previous meeting, 3/7/16, be approved.  
Supported by Tollison. Aye (6) Nay (0) Absent (1) Motion carried.

Invoices were presented to council in printed form by accounts: General fund- \$21,829.28 Police fund- \$338.05; Major St.-\$1,934.18; Local St.- \$1,934.17; Sewer fund- \$11,039.90; Water fund- \$8,553.17 for a total of \$45,628.75 Moved by Bruckner that the invoices as presented be approved and checks drawn for the same.  
Supported by Richards. Roll Call Vote: Aye (6) Nay (0) Absent (1) Motion carried.

Mayor Holeman contacted MML regarding possibility of a BMX ramp park in the city and was informed with proper signage it is allowed. An approved contractor must construct it and dirt jumps are not allowed. Vacant city lot on south side of Chestnut is a possible location. Mayor waiting to receive further details from MML and will contact City of Monroe for information about their park.

City of Petersburg needs to establish a FOIA rate system. Clerk is working on it and will consult with attorney.

Tony Fietz advised that no decision has been made regarding his driveway. Discussed adding cement to city basketball court versus replacing the whole court along with new backboard systems. Haller will talk to Rec Commission director asking for money toward project. Mr. Fietz will get suggested court size to Mayor for bids.

Mayor Holeman presented bids from Cadillac Asphalt to repave Vesey and Railroad Streets and will be talking to another representative from Cadillac to see if he can get it lower. Discussed turning Railroad to gravel or eliminating that section of street. Bruckner to contact state regarding eliminating Railroad section.

Moved by Haller to accept bid from DG Slurry Seal of Toledo to slurry seal portions of Elm, W. Walnut, W. Albain and Wood Streets including crack filling for \$51,512.50. Supported by Tollison.  
Roll Call Vote: Aye (6) Nay (0) Absent (1) Motion carried.

Mayor reported that bulk water plant is as good as it can be. If not acceptable, may need to purchase a different meter.

Moved by Richards to adopt Resolution acknowledging former Clerk Lori Ivan for her 12 years of service.  
Supported by Bauer. Aye (6) Nay (0) Absent (1) Motion carried.

Moved by Richards that the City of Petersburg Council endorse the Monroe County Technology Millage Renewal in May. Supported by Tollison. Aye (6) Nay (0) Absent (1) Motion carried.

Moved by Bruckner that Council adjourn at 8:04pm. Supported by Tollison. Aye (6) Nay (0) Absent (1) Motion carried.
