A Regular Meeting of the Council for the City of Petersburg was held on the above date.  
The Meeting was called to order at 7:00 p.m. by Mayor Holeman.  
Councilpersons present were Terri Bauer, Charles Bruckner, Fred Degner, Richard Haller, Lawrence Schadewald and Joanne Tollison.

Moved by Degner that the minutes of the previous meeting, 07/02/2012 be approved.

Jodi Russ from the MCLS came into talk about the library renewal issue that will be on the ballot in August.

Invoices were presented to Council in printed form by accounts: General Fund-\$30,130.08;  
Police Fund-\$25,988.72; Major Streets-\$886.89; Local Streets-\$0; Sewer Fund  
\$5,988.00; Water Fund- \$3,779.91; for a total of \$66,773.60  
Moved by Bruckner that the invoices as presented be approved and checks drawn for the same.  
Supported by Tollison. Roll Call Vote: Aye (7) Nay (0) Motion carried.

Moved by Bruckner that the Fire Contract be continued with hopes of getting a 3 year contract and all other details remaining the same  
Supported by Tollison. Aye (7) Nay (0) Motion carried.

Moved by Schadewald that we add to the bills the purchase of playground equipment for the Tot Lot – not to exceed \$1,850.00.  
Supported by Bauer. Aye (7) Nay (0) Motion Carried.

Moved by Bruckner that the clerk has permission to appoint as many election inspectors as needed.  
Supported by Bauer. Aye (7) Nay (0) Motion Carried.

Deputy Rosenberger will not be here for Community Days. Terri Bauer has taken care of security for the event.

Water line construction has started at the road commission property today.  
Holeman will try to get someone from The American Tower Project to come to the next meeting to clarify options and answer questions about the cell tower payoff.  
The painting of the water tower was discussed. It will cost about \$130,000 and needs to be done next year.  
Sidewalk by the library will be started after Community Days.  
Bauer talked about putting a box for used cell phones in the City Building to support “Cell Phones for Soldiers.”
