A Regular Meeting of the Council for the City of Petersburg was held on the above date.  
The Meeting was called to order at 7:00p.m. by Mayor Holeman.

Moved by Bruckner that council accept the bid provided by the Chair of the Planning Com. From Carlisle Wortman to update the City's Zoning book and maps in order to keep the city in compliance. Supported by Tollison. Aye (6) Nay (0) Absent (1) motion carried

Tony Fietz inquired as to the status of the park updates and improvements.

Moved by Tollison that the city move forward with the tree trimming project and award it to Aardvark contingent on them providing proof of insurance. Supported by Haller Aye (6) Nay (0) Absent (1) Motion carried

Sheriff Dept. activity shared by mayor.

Moved by Bruckner that Council accept the newly prepared contract for the position of Building Inspec. As presented in written form to be entered into w/ the City's current inspector providing he is in agreement. Supported by Schadewald Aye (6) Nay (0) Absent (1) motion carried.
