A Regular Meeting of the Council for the City of Petersburg was held on the above date.
The Meeting was called to order at 7:00 p.m. by Mayor, James W. Holeman
Councilpersons present were Terri Bauer, Charles Bruckner, Rich Haller, Kevin Richards, Lawrence Schadewald and Joanne Tollison. Absent:

Minutes of the last meeting were presented to Council in printed form as recorded.
Moved by Haller that the minutes of the previous meeting, 9/5/16, be approved.
Supported by Tollison. Aye (7) Nay (0) Absent (0) Motion carried.

Invoices were presented to council in printed form by accounts: General fund- \$18,953.70; Police fund- \$669.73; Major St.-\$0; Local St.- \$0; Sewer fund- \$6,392.00; Water fund- \$6,590.76 for a total of \$32,606.19. Moved by Richards that the invoices as presented be approved and checks drawn for the same. Supported by Bauer. Roll Call Vote: Aye (7) Nay (0) Absent (0) Motion carried.

Chris Kull and Sue Donovan, representing the Monroe County Bicentennial Alliance Committee, gave a short presentation promoting their cause, Monroe County turning 200 in 2017, and asked for the City's support.

Moved by Haller to adopt the Resolution to Recognize the Monroe County Bicentennial Alliance. Supported by Bauer. Aye (7) Nay (0) Absent (0) Motion carried.

Mayor reported that he received further information regarding a new police vehicle. The cost of vehicle (Ford Explorer 4x4) is \$28,000, \$1000 for striping/decals, \$9294 for equipment. Bauer asked if warranty is included and if an extended warranty can be purchased.

Moved by Bauer to sign title of old police car over to sheriff department in exchange for use of a vehicle until a new car is delivered. Supported by Tollison. Aye (7) Nay (0) Absent (0) Motion carried.

Moved by Schadewald to support 2 incumbents running for Michigan Municipal League Board of Directors. Supported by Haller. Aye (7) Nay (0) Absent (0) Motion carried.

Mayor reported the high service pump is still not repaired and he's asked them to rush it.

Mayor has been discussing the Safe Routes to School project with Dave Kubiske to address concerns by the residents on Elizabeth Street.

It has been noticed that cars are still driving the wrong way down Elm Street in front of the school. More signage will be added.

Jim Ross from MCCC gave a presentation on the upcoming 5 year/.85 millage for maintenance and improvements of buildings at the college. Further information is available at www.monroecc.edu/millage.

Schadewald asked if the DPW buildings at the end of Center Street could be painted as they are looking bad.
