Kylie Shroeder and Connie Jensen from the Petersburg Events Committee reported a Farmers' Market will take place the 4th Saturday of June-September from 9am-2pm. Movie in the park will be the same dates at sundown. They are also planning a Gala September 6 at the VFW to raise funds for an ice rink. Tickets are \$45 for a comedy show, dinner and drinks. They are planning Halloween Bingo and a holiday event on November 29.
