Public Comment:

President Kojo Quartey spoke about the upcoming Maintenance Improvement Millage 5 year renewal, which is on the November 4th ballot, and how important it is for the millage to pass. He also spoke about how enrollment, at the college, has increased over the last few years.

Deanna Hutsell from EGLE presented a report on the findings of the Van Deilen property and the different stages it will be going through to get it environmentally safe. She explained what each stage would entail and the processes that will be going on. This is an estimated 3 to 5 year project.

Heather Smith, who is the Brownfield Development Coordinator with EGLE, talked about how her division can help with redevelopment to revitalize communities. There is help with costs that is available through state funding for redevelopment. Some of this funding is available through grants and low interest loans. She explained 1. Site Assessments 2. Baseline Environmental Assessments and 3. Tax Increment Financing.

Mayor Holeman briefly discussed the letter from David Arthur Consultants about the importance of street maintenance.
